

### FROM THE MANAGER

Our Fund delivered a positive return of +1,8% over the past month, marking a solid start to 2026.

Equity markets continue to move higher. Interestingly, US technology companies have lagged the broader market, which has been beneficial for our current positioning.

Our fixed-income investments are performing in line with expectations, providing stability and steady returns within the portfolio.

We increased our exposure to commodities and exited our silver position after a strong run, locking in gains.

While we remain cautious given the current market environment, we are optimistic for the remainder of the year.



Blue Ship Patrimoine is a diversified wealth fund that invests across different asset classes, both in liquid and illiquid investments. The fund adopts a defensive strategy that aims at maximizing capital gains while limiting risk and volatility. Equity exposure typically ranges from 20% to 40%. Illiquid investments are capped to 35%.




