PRESENTATION

Blue Ship Patrimoine is a diversified wealth fund that invests across different asset classes, both in liquid and illiquid investments. The fund adopts a defensive strategy that aims at maximizing capital gains while limiting risk and volatility. Equity exposure typically ranges from 20% to 40%. Illiquid investments are capped to 35%.

FROM THE MANAGER

The fund performance for the month was satisfactory, supported by a rebound in global equity markets as commercial tensions began to deescalate. Equity positions, particularly in European funds, delivered appreciable gains.

Despite recent market strength, we remain highly cautious. Valuations appear stretched and in our view, markets are showing signs of complacency in the face of ongoing macroeconomic and geopolitical uncertainty.

Gold continued to perform well, reinforcing its role as a stabilizer within the portfolio. We continue to maintain a high level of cash as a defensive posture. This also positions us to efficiently deploy capital into our first private debt investment, which is scheduled for the beginning of June 2025.


