Our Fund delivered a positive return of +0,7% over the past month, closing the year with a +9,2% annual performance.

Our equity investments ended the year slightly positive, supported by broadly favourable market conditions. Equity markets continue to follow an upward trend.

Our fixed-income investments continue to perform in line with expectations, providing stability and steady returns within the portfolio.

We have built a meaningful allocation to commodities, with exposure to gold, silver, and a diversified commodities fund. We have a constructive outlook on commodities.

Looking ahead, we have good investment ideas for 2026 and remain cautiously optimistic as we continue to navigate the evolving market environment.

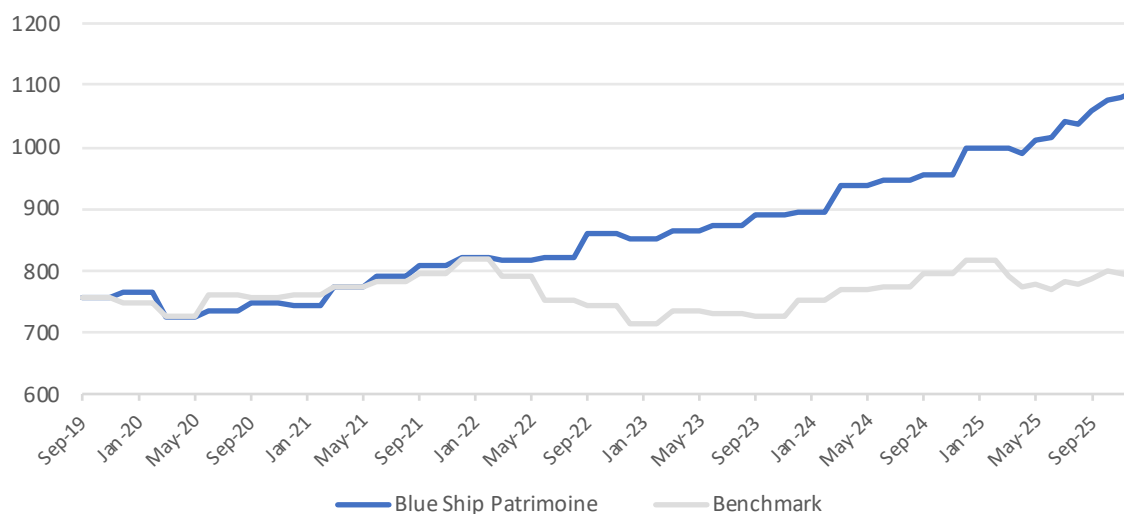

Blue Ship Patrimoine is a diversified wealth fund that invests across different asset classes, both in liquid and illiquid investments. The fund adopts a defensive strategy that aims at maximizing capital gains while limiting risk and volatility. Equity exposure typically ranges from 20% to 40%. Illiquid investments are capped to 35%.
